The FY16 grant did not fully expend \$11,326 of the leasing/rental assistance funds. This was due to turnover of households during the program year and subsequent changes to the rent calculations of program participants.

The Samaritan Housing Program is operated by the Anne Arundel County Mental Health Agency. The Samaritan Housing Program provides scattered site rental assistance as well as case management, mental health, and supportive services for five chronically homeless persons. The program targets chronically homeless individuals diagnosed with a severe mental illness. Services are provided by mental health professionals and are client driven. The program participates in the County's Coordinated Assessment for permanent supportive housing programs. The County uses the VI-SPDAT as its assessment tool which produces a centralized waitlist of the County's most vulnerable homeless individuals. The Samaritan Program accepts the highest ranked (most vulnerable) client eligible to the program. The Mental Health Agency has adopted the Housing First model into the operation of the Samaritan Program.
