## 3B. Project Description

## 1. Provide a description that addresses the entire scope of the proposed project.

The Anne Arundel Partnership for Permanent Housing serves homeless families and individuals. The program provides leasing assistance and support services through three different agencies, the Housing Commission of Anne Arundel County, Arundel House of Hope, Inc. and Community Residences, Inc. Arundel Community Development Services is the project subrecipient. The Housing Commission provides tenant based rental assistance and Community Residences provides intensive case management to those households receiving the rental assistance. Arundel House of Hope uses a portion of the funds to rent three supportive community houses for single, disabled homeless men creating a total of 9 SRO units. The program prioritizes chronically homeless persons as turnover beds become available. Additionally, a portion of the grant is provided to the Anne Arundel County Department of Social Service for the administration and operation costs of the County's HMIS system. 
