### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The Community Housing Program, administered by Arundel House of Hope, Inc., (AHOH) is a permanent supportive housing program for three homeless men and three homeless women, of which, four must meet HUD’s chronically homeless definition, per initial grant application. However, all new clients will meet the chronically homeless definition. AHOH leases two properties from landlords in the community to provide supportive shared housing for homeless individuals.

AHOH employs the Housing First model of care, a HUD recognized best practice, in its programs and makes housing the first priority for persons served regardless of their situation and recognizes that safe, decent and affordable housing is an important component of individual health. As of November 2013, AHOH participates in the County’s coordinated assessment and receives referrals through this process. Specifically, the County maintains a list of all homeless individuals and families prioritized by a vulnerability index (developed by 100,000 Homes) and utilized as part as County’s Coordinated Intake Process. The program accepts the next highest priority or most chronically homeless, vulnerable individual from the list as long as that individual meets all the requirements of the original grant application.

Participants then sign a lease agreement with Arundel House of Hope and work with the case manager and receive additional services through the Resource and Day Center and other service providers. We partner and link each participant to other service providers allowing them to access many different services. Supportive services are client-driven and individually tailored to the needs of each participant. Program participants are involved in setting the personal goals and the type and pace of services they need to assist with goal achievement. Program services support the participant's efforts to increase their incomes and maximize their ability to stable living include: (a) client advocacy to assist them in obtaining benefits and entitlements, including social security, public assistance, and food stamps; (b) service coordination for medical and psychiatric treatment, substance abuse treatment, counseling, and other supportive services; (c) appointment escorts; (d) employment counseling skills training, and vocational counseling; (e) budgeting and financial management to ensure essential bills such as rent is paid in a timely manner; and (f) providing opportunities for socialization.

However, if you lose your section 509(a)(1) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(1) organization.

If we have indicated in the heading of this letter that an addendum applies, the addendum enclosed is an integral part of this letter.

Because this letter could help resolve any questions about your private foundation status, please keep it in your permanent records.
