3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Lack of adequate and affordable housing in Anne Arundel County, Maryland continues to be the number one challenge facing people with mental illness.

This Continuum of Care (CoC) program, a Shelter Plus Care permanent supportive housing renewal project, will continue to provide tenant-based rental assistance based on HUD's eligibility criteria for fourteen (14) individuals and twelve (12) families with an adult member who has a serious mental illness and is experiencing homelessness in Anne Arundel County, Maryland. The project rental assistance will be matched with an array of support services including case management or psychiatric rehabilitation service depending on the participants choice. Additionally, its capacity to serve participants in this project will actually exceed the budgeted number being requested due to cost savings. The program is currently serving thirty one (31) households with eight (8) of them serving families which is five more than HUD's funding formula for this grant supports.

The project operates with a commitment to the Housing First approach and an emphasis on serving individuals experiencing chronic homelessness. It provides its program participants with a full array of supportive services, including in-kind match of \$56,997 in psychiatric rehab services and \$51,528 in specialized/individualized case management with linkage to appropriate community supports and resources, connection to entitlements, assistance in accessing community resources such as furniture, food, clothing, etc. and advocacy. The state of Maryland's Behavioral Health Administration, works closely with the Anne Arundel County Core Service Agency, will continue to offer collaborative services to ensure the continued ongoing success of the program.

A key objective of the Anne Arundel County Core Service Agency is to continue providing effective, quality supportive services and housing to people who are experiencing homelessness and have a mental illness while simultaneously meeting the increased demand for assistance. Anne Arundel County continually collaborates with community leaders and providers to find innovative and creative ways to serve the behavioral health and homeless populations throughout the county. The HUD CoC Shelter Plus Care program provides a positive example of what can be done to support this target population. In the CoC Shelter Plus Care project during the most recent operating year, the average length of stay for the program participants who remained in the program was 2859 days -- that's the equivalent of nearly eight years per participant in the program. Anne Arundel County is striving to improve these numbers in the future, with a vision of no person experiencing homelessness.

The Anne Arundel County Mental Health Agency will make available several in-kind resources to support this project. Our office will provide a portion of two staff positions to provide fiscal oversight and invoice preparation, technical assistance in placements and maintaining placements, liaison with the Behavioral Health Administration, technical assistance to case managers, landlords and consumers. The value of these services is \$9,500. In addition, the Anne Arundel County Mental Health Agency will make funding available through our purchase of service, flexible funding with a value of \$8,538. The total value of AACMHA's contribution is \$18,038 for the period of July 1, 2019 – June 30, 2020.
