Purpose of Annual Action Plan: The Annual Action Plan presents a detailed strategy for the use of CDBG, HOME, ESG, HOPWA and COC grant funds expected to be received by the County during Local Fiscal Year 2021 to implement eligible activities in achieving first year objectives of the County *Consolidated Plan: FY 2021 – FY 2025*. The Annual Action Plan also includes proposed amendments to previous Action Plans.

Public Comments on Annual Action Plan: The Draft Annual Action Plan for LFY 2021 will be available on the website of Arundel Community Development Services, Inc. (ACDS) beginning May 23, 2020.
