The Community Housing Program, administered by Arundel House of Hope, Inc., (AH0H) is a permanent supportive housing program for three homeless men and eight homeless women, all of whom meet HUD's chronically homeless definition. AHOH leases three properties from landlords in the community to provide supportive shared housing for homeless individuals.

AHOH employs the Housing First model of care, a HUD recognized best practice, in its programs and makes housing the first priority for persons served regardless of their situation. AHOH recognizes that safe, decent, and affordable housing is an important component of individual health and stability. As of November 2013, AHOH participates in the County's coordinated assessment system and receives all referrals through this process. Specifically, the County maintains a list of all homeless individuals and families prioritized by a standardized vulnerability index, the VI-SPDAT, and this list is utilized as part of the County's Coordinated Intake Process. The program accepts the highest priority or most chronically homeless, vulnerable individual from the list.

Participants sign a one-year lease agreement with AHOH and work with a case manager on individualized service plan goals geared at increasing selfsufficiency and maintaining housing. AHOH partners with and links participants to other service providers allowing them to access many different services. Supportive services are client-driven and individually tailored to the needs of each participant. Program participants are involved in setting the personal goals and the type and pace of services they need to assist with goal achievement. Program services support the participant's efforts to increase their incomes and maximize their ability to stable living include: (a) client advocacy to assist them in obtaining benefits and entitlements, including social security, public assistance, and food stamps; (b) service coordination for medical and psychiatric treatment, substance abuse treatment, counseling, and other supportive services; (c) appointment escorts; (d) employment counseling skills training, and vocational counseling; (e) budgeting and financial management to ensure essential bills such as rent is paid in a timely manner; and (f) providing opportunities for socialization.



VAWA Budget

New in FY2023, the Violence Against Women Act (VAWA) has clarified the use of CoC Program funds for VAWA eligible cost categories. - Moving Costs. Assistance with reasonable moving costs to move survivors for an emergency transfer(s).

- Travel Costs. Assistance with reasonable travel costs for survivors and their families to travel for an emergency transfer(s). This may include travel costs to locations outside of your CoC's geography.

- Security Deposits. Grant funds can be used to pay for security deposits of the safe unit the survivor is transferring to via an emergency transfer(s).

- Utilities. Grant funds can be used to pay for costs of establishing utility assistance in the safe unit the survivor is transferring to.

- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.

- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).

- Technology to make an available unit safe. 
