### Laurel Race Course Impact Fund FY 2024 Accomplishments

#### Overview of grant awards:

- 16 awards were granted with \$437,001.84;
- A total of 23,963 residents were assisted with this funding with 94% (of reported numbers) having low to moderate income;
- 846 Youth were impacted with this funding;
- 73 Elderly were impacted with this funding;
- 70 residents with disabilities received services;

As grantees continue to report on their accomplishments these numbers will increase.

## FY 2026 Grant Process

**Fiscal Year (FY) 2026** – July 1, 2025 – June 30, 2026

Community Grants – Nonprofit organizations and community associations serving communities and residents generally within the 3-mile radius can apply for up to \$50,000

▶ Open to 501(c)3 and 501(c)4 organizations

Serving residents within the 3-mile radius if Laurel Racetrack

• Laurel Advisory Committee reviews applications and invites applicants to make presentations
