This permanent supportive housing (PSH) project is administered by the Anne Arundel County Mental Health Agency, Inc (AACMHA), under the direction of the MD Department of Health- Behavioral Health Administration. This project will continue to provide tenant-based rental assistance based on HUD's eligibility criteria for fourteen (14) individuals and twelve (12) families with an adult member who has a serious mental illness(SMI), who is experiencing chronic homelessness and homelessness in Anne Arundel County, Maryland. The project's rental assistance will be matched with an array of support services including case management or substance use treatment, psychiatric rehabilitation services depending on the participant's choice. Due to the consistency of cost savings in past competitions, the project is projected to increase its capacity to serve participants in excess of the budgeted number being requested. In the past FY, the project was able to assist 32 households, six (6) more households than HUD's funding formula for this grant supports.

The project operates with a commitment to the Housing First approach and an emphasis on serving individuals who have a SMI who are experiencing chronic homelessness. It provides its program participants with a full array of supportive services, including psychiatric rehabilitation services, specialized/individualized case management, linkage to appropriate community supports and resources, connection to entitlements, assistance in accessing community resources such as furniture, food, clothing, and advocacy based on the needs and choice of the participants. Individuals participating in the program who express a desire to work are linked to supported employment service, to include workforce training.

A key objective of the AACMHA is to continue providing effective, quality supportive services and housing to individuals who are experiencing homelessness and have a serious mental illness while simultaneously meeting the increased demand for assistance. Anne Arundel County continues to collaborate with community leaders and providers to find innovative and creative ways to serve the behavioral health and homeless populations throughout the county.

The lack of adequate and affordable housing in Anne Arundel County, Maryland continues to be the number one challenge facing individuals who have a serious mental illness. AACMHA and the participant's providers have developed partnerships with private landlords and property management companies. The relationships built with these partners have been important in preventing homelessness and sustaining housing as finding available units became increasingly difficult.





Any questions you may have concerning your liability for FICA or FUTA taxes should be addressed to the Internal Revenue Service, Office of the Associate Chief Counsel (Employee Benefits and Exempt Organizations) CC:EBEO, Room 5213, P.O. Box 7604, Ben Franklin Station, Washington, D.C. 20044.

Unless you are specifically excepted, you are required to file Form 990, Return of Organization Exempt From Income Tax, if your gross receipts each year are normally more than \$25,000. Such return is not required to be filed by an organization that is exempt from tax under section 501(a) of the Code and that is a state institution, the income of which is excluded from gross income pursuant to section 115 of the Code. If you believe you are not required to file Form 990, you may request a ruling from the Exempt Organizations Division addressed to Internal Revenue Service, Attn: CP:E:EO, P.O. Box 120, Ben Franklin Station, Washington, D.C. 20044.

If you are required to file Form 990, but your gross receipts each year are not normally more than \$25,000, we ask that you establish that you are not required to file Form 990 by completing Part I of that Form for your first year. Thereafter, you will not be required to file a return until your gross receipts exceed the \$25,000 minimum. For guidance in determining if your gross receipts are "normally" not more than the \$25,000 limit, see the instructions for the Form 990. If a return is required, it must be filed by the 15th day of the fifth month after the end of your annual accounting period. A penalty of \$10 a day is charged when a return is filed late, unless there is reasonable cause for the delay. The maximum penalty charged cannot exceed \$5,000 or 5 percent of your gross receipts for the year, whichever is less. This penalty may also be charged if a return is not complete, so please be sure your return is complete before you file it.

You are required to make your annual return available for public inspection for three years after the return is due. You

are also required to make available a copy of your exemption application, any supporting documents, and this exemption letter. Failure to make these documents available for public inspection may subject you to a penalty of \$10 per day for each day there is a failure to comply (up to a maximum of \$5,000 in the case of an annual return). See Internal Revenue Service Notice 88-120, 1988-2 C.B. 454, for additional information.

You are not required to file federal income tax returns unless you are subject to the tax on unrelated business income under section 511 of the Code. If you are subject to this tax, you must file an income tax return on Form 990-T, Exempt Organization Business Income Tax Return. In this letter we are not determining whether any of your present or proposed activities are unrelated trade or business as defined in section 513 of the Code.

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, if it is determined that you are a private foundation, you will be subject to excise taxes under Chapter 42. You also may be subject to other federal excise taxes. If you have any questions about excise, employment, or other federal taxes, please contact your key district office.

Donors may deduct contributions to you as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of Code sections 2055, 2106, and 2522.

Contribution deductions are allowable to donors only to the extent that their contributions are gifts, with no consideration received. Ticket purchases and similar payments in conjunction with fund-raising events may not necessarily qualify as fully deductible contributions, depending on the circumstances. If your organization conducts fund-raising events such as benefit dinners, shows, membership drives, etc., where something of value is received in return for payments, you are required to provide a written disclosure statement informing the donor of the fair market value of the specific items or services being provided. To do this you should, in advance of the event, determine the fair market value of the benefit received and state it in your fund-raising materials such as solicitations, tickets, and receipts in such a way that the donor can determine how much is deductible and how much is not. Your disclosure statement should be made, at the latest, at the time payment is received. Subject

to certain exceptions, your disclosure responsibility applies to any fund-raising circumstance where each complete payment, including the contribution portion, exceeds \$75. In addition, donors must have written substantiation from the charity for any charitable contribution of \$250 or more. For further details regarding these substantiation and disclosure requirements, see the enclosed copy of Publication 1771. For additional guidance in this area, see Publication 1391, Deductibility of Payments Made to Organizations Conducting Fund-Raising Events, which is available at many IRS offices or by calling 1-800-TAX-FORM (1-800-829-3676).

In this letter, we have not determined the effect on your tax-exempt status of financing your activities with the proceeds of tax-exempt bonds since you have not indicated that you intend to use such methods now or in the future.

You need an employer identification number even if you have no employees. Please use that number on all returns you file and in all correspondence with the Internal Revenue Service.

We are informing your key district office of this ruling. Because this letter could help resolve any questions about your exempt status and foundation status, you should keep it in your permanent records.
