The funds will be used primarily to strengthen CoC's ability to effectively continue to implement HUD mandates and end homelessness through the following efforts:

- 1) improve CoC ability to decrease the length of time someone is homeless by improving the performance of the County emergency shelter program and by improving transitional and permanent housing placements;
- 2) continue to implement strategic plans and efforts to end veteran, chronic, family, and youth homelessness;
- 3) identify, evaluate, and alleviate racial disparities and their relationship with entry to, experience within, and success through the homeless system, including evaluate tools, such as VI-SPDAT, to ensure racial disparity is reduced:
- 4) offer training to CoC members on diversity, equal access, anti-discrimination, Trauma Informed Care, SOAR, and other evidence-based and best practices that will improve services to homeless;
- 5) implement County funding to create new and expand TBRA programs for homeless persons, at-risk families, and veterans;
- 6) continue incorporating the Housing First approach throughout the Continuum of Care:

- 4) further develop the County's by-name list used as a referral tool for rapid rehousing programs by December 2026;

The Management Plan:

Arundel Community Development Services, Inc. (ACDS) has administered federal funds, developed affordable housing strategies, furthered fair housing, and implemented housing and community development activities in Anne Arundel County, Maryland since its inception in July of 1993. ACDS is responsible for administering and managing the County's federally funded Community Development Block Grant Program, HOME Investment Partnerships Program, the Emergency Solutions Grant Program, Housing Opportunities for Persons with AIDS Program and the Continuum of Care programs. The CEO and Planning staff meet regularly to oversee the status of each task as well as to evaluate performance. The CoC Board meets monthly and has an established board, committees and work groups to continue to work on all tasks and to complete them by the established deadlines outlined above.

Erin Karpewicz, Chief Executive Officer, brings years of experience in managing State, federal and local housing and community development activities. In her role as CEO of ACDS, she oversees several housing programs providing direct services to low and moderate income households, and is responsible for administering the County's CDBG, HOME, ESG, HOPWA, and CoC programs. Elizabeth Brush, Planning Director, brings 20 years of experience administering the CoC planning process, CoC funded grants and ESG. She has successfully developed a strategic plan for addressing the needs of the homeless. Hannah Breakstone, MSPH, CoC Planning and Grants Manager, brings experience working with system change and planning services and administers public service and community development grants. She works closely with the CoC's homeless sub-grantees on compliance with applicable local, state, and federal

regulations, monitors grantee programs, reviews and approves grantee invoices and provides technical assistance. "
